

DORNEY MEMORIAL SOCIETY.  
ARTICLES OF THE SOCIETY.

**1. NAME.**

The Society shall be known as 'THE DORNEY MEMORIAL SOCIETY' (D.M.S.).

**2. OBJECT.**

The object of the Society is to help the Dorney Parish Council to care for and tend throughout the years to come the 1939-45 War Memorial to the end that it may be regarded by Parishioners with pride as a fitting and enduring token of their esteem for their fellow Parishioners who gave their lives for their Country in the War.

**3. MEMBERSHIP.**

(a) Membership of the Society shall consist of :-

The Chairman of Dorney Parish Council.

The Vice Chairman of Dorney Parish Council.

The Chairman of the Finance Committee of Dorney Parish Council.

A Representative of the Dorney Horticultural Society, together with such Parishioners as are ready and willing to work to achieve the object of the Society.

**4. ORGANISATION.**

- (a) There shall be at least one meeting a year to consider progress and to make arrangements for the following year.
- (b) An official shall be elected to carry out the function of Chief Whip for the year and he may arrange for such assistant Whips as he may find necessary.

(c) The Society may appoint such advisers as it may consider desirable and has so appointed Mr. W.H. Bowles (Head groundsman of Eton College and President of the Groundsmen's Association).

5. RELATIONSHIP WITH DORNEY PARISH COUNCIL.

- (a) The Society will be ready to carry out the wishes of the Parish Council, who provide the necessary finance from the Rates.
- (b) The Society will NOT incur any expense without first obtaining the approval of the Standing Committee of the Parish Council, the individuals of which Committee are Founder Members of the Society.
- (c) The Society may make recommendations to the Parish Council for the improvement of the War Memorial.

6. RELATIONSHIP WITH DORNEY HORTICULTURAL SOCIETY.

Dorney Horticultural Society are prepared to offer advice and to obtain certain materials at a discount for the use of the Society and to this end have a representative as a Founder Member of the Society.
